



Participant Waiver and Release Form

In consideration of being permitted to participate in any way in any activities related to the **FREEDOM TOUR** (the "TOUR") I hereby take the following actions for myself, my personal representatives, assigns, heirs, successors, executors, administrators, and next of kin:

I acknowledge, agree, and represent that I understand the nature of bicycling activities and that I am properly trained, qualified, in good health, and in proper physical condition to participate in the TOUR. I further acknowledge that the TOUR will be conducted over public roads and facilities open to the public during the TOUR and upon which the hazards of traveling are to be expected. I further agree and warrant that if, at any time, I believe conditions to be unsafe, I will immediately discontinue further participation in the TOUR. I agree to abide by any decision of the TOUR organizers, volunteers, and representatives regarding my ability to safely complete and participate in the TOUR.

I fully understand that:

- (a) Bicycling activities involve risks and dangers. I acknowledge that such risks and dangers include, but are not limited to death, illness, serious bodily injury, and property loss ("Risks").
- (b) These Risks and dangers may be caused by my own actions or inactions, the actions or inactions of others participating in the TOUR, the condition in which the TOUR takes place, or the negligence of the "releasees" named below.
- (c) There may be other risks and social and economic losses either not known to me or not readily foreseeable at this time.

I fully accept and assume all such risks and all responsibility for losses, costs, and damages I incur as a result of my participation or that of the minor in the TOUR.

I hereby release organizers of the TOUR, its sponsors, advertisers, partners and beneficiaries, its leaders, its employees, and volunteer staff, other participants, and, if applicable, owners and lessors of premises on which the TOUR takes place, (each considered one of the "Releasees" herein) from any liability whatsoever arising out of injury, sickness, or damage, which may be sustained by me during the course of the TOUR.

I understand that my insurance coverage will be used as a primary coverage in the event medical intervention is needed. I do further give my consent for the director or properly appointed leader of the TOUR to secure the administration of medical treatment or medication for myself in case of an emergency. I do further agree to the performance of treatment deemed necessary for me in the opinion of the attending physician. I agree to assume full responsibility for all costs of such treatment.

I hereby indemnify and hold harmless all Releasees from any and all liabilities or claims made by other individuals or entities as a result of any of my actions during the TOUR, including any litigation, expenses, attorney's fees, loss, liability, damage or cost which may occur as a result of any such claims.

I hereby release, discharge, and covenant not to sue any of the Releasees from all liability, claims, demands, losses, or damages on my account caused or alleged to be caused in whole or in part by the negligence of the Releasees or otherwise, including negligent rescue operations; and I further agree that if, despite this release and waiver of liability, assumption of risk, and indemnity agreement I, or anyone on my behalf, makes a claim against any of the Releasees, I will indemnify, save, and hold harmless each of the Releasees from any litigation expenses, attorney fees, loss, liability, damage, or cost which any may incur as the result of such claim.

I understand that while I participate in any activities associated with the TOUR, I am responsible to abide by the rules set forth by the sponsoring organization, its leaders, and supervisory personnel. Any serious infraction of the rules and/or conduct by myself can result in dismissal from the TOUR. I, the undersigned, agree to assume the cost of such actions. I also agree to forfeit any possible refund.



I understand that Timberline Church and Project Rescue are non-profit organizations and contributions are tax-deductible with the exception of cash. Timberline Church and Project Rescue have complete discretion and control over use of all donated funds. Donations and payments are non-refundable and non-transferable.

I hereby consent to the use of any video recordings, photographs, slides, audio recordings, or any other visual or audio reproduction in which I may appear by organizers of the TOUR, their partners and beneficiaries. I understand that these materials may be used for promotion of FRONT RANGE FREEDOM TOUR, their partners and beneficiaries, which includes fundraising efforts.

I release organizers of the TOUR, their partners and beneficiaries from any liability connected with the use of my picture or voice recordings as part of any promotional or fundraising program.

As a team member of the TOUR, I will make every effort to maintain a positive and flexible attitude at all times. I will strive to work in unity with my team, my leaders, and the host. I will approach the culture and customs of the community I am visiting with respect and without complaint. I will submit to the leadership of the TOUR and work in whatever way is required and needed of me and will stay with the group at all times. I will do my best to be rightly related to everyone. I understand that appropriate action will be taken if I disregard these matters of conduct.

I understand that my attendance at Team Preparation Communications and/or Meetings is mandatory and that I may jeopardize my opportunity to participate in this trip if I do not comply.

The Information that I have given to organizers of the TOUR is accurate and true to the best of my knowledge. My signature below signifies my approval of all limitations listed above.

I certify that I am at least 18 years of age on the date hereof. I have carefully read this Waiver and Release of Liability, I fully understand its contents, and I sign of my own free will. I am aware that this is a waiver and release of liability and I intend it to be a complete and unconditional release of all liability to the greatest extent allowed by law. I agree that if any portion of this agreement is held to be invalid the balance, notwithstanding, shall continue in full force and effect.
